JOB TITLE: Special Education Behavior Support Specialist

Description of Basic Functions and Responsibilities:

Under the direction of District Administration, provides specialized support to students with special needs; monitor, assess and adjust environmental or Behavior Intervention Plans, and instructional strategies and activities to meet the needs of identified students; trains Paraeducators and other District staff regarding the autism spectrum and other disorders as needed. Assists in modifying curriculum.

Directly Responsible To:

Classroom Teacher Resource Specialist for Special Education Site Administration

Examples of Duties

- 1. Provides specialized support to students with special needs including, but not limited to; Autism, Downs Syndrome and others mainstreamed in general education classrooms and in the resource classroom
- 2. Monitors, assesses, and adjusts instructional, environmental and behavior modification activities in response to student needs, problems and progress.
- 3. Assists in developing, implementing, and conducting in-services and training activities concerning behavior modification and related principles, standards, issues, guidelines, practices, procedures, plans, strategies and techniques for staff and others.
- 4. Participates in the design, development and implementation of IEP goals, objectives and behavior planning.
- 5. Observes and assesses classrooms and instructional activities to support a positive and structured environment for students with special needs, recommends modifications classroom environments as appropriate.
- 6. Compiles data and information, and prepares and maintains various IEP records, reports and files related to students, progress, observations, performance, behavior and assigned activities.
- 7. Operates a variety of standard office equipment including a computer and assigned software, including IEP programs.
- 8. Understands the student IEP data within the IEP system (e.g., SIRAS) and the California School Information System (e.g., CALPADS). (Is the backup person for these programs.)
- 9. Applies specialized techniques/strategies such as behavior intervention strategies and assistive technology (if needed) as required.
- 10. Prepares instructional materials and cleans up after activities
- 11. Supervises students and assists in maintaining order on the yard, playground, lunch area and during other school activities such as field trips.

- 12. Assists special needs students in learning and following classroom routines.
- 13. Accompanies students going from one location to another, if needed.
- 14. Assists certificated staff in administering a variety of formal and informal assessments.
- 15. Assists with student's hygiene if needed.
- 16. Cross trained to cover other District SPED Aide positions including; Special Education/Special Needs Aide, 1-1 Specialist Aide, and Special Education Aide (see job descriptions).
- 17. Performs other duties as assigned.

Required Qualifications:

- 1. Principles, practices and techniques involved in the monitoring, analysis and treatment of students with special needs.
- 2. Child guidance principles and practices related to children with disabilities.
- 3. Principles, practices and methods used in the assessment of student needs, behavioral problems and progress.
- 4. IEP practices, procedures and techniques.
- 5. Instructional methods, strategies and techniques related to students with Autism and other identified needs.
- 6. Knowledge of problems and concerns of students with special needs.
- 7. Operation or standard office equipment including a computer.
- 8. Oral and written communication skills.
- 9. Interpersonal skills using tact, patience, courtesy and confidentiality.
- 10. Record-keeping techniques.
- 11. Development and implementation of a Behavior Implementation Plan.
