Student Acceptable Use Agreement

The Spring Grove School (hereafter referred to as SGS) is now offering Internet access for student use. This document contains the Acceptable Use Agreement for your use of all computers, software and internet access while at Spring Grove School (thereafter referred to as The SGS Computer Network).

A. Educational Purpose

1. The SGS Computer Network has been established for a limited educational purpose. The term "educational purpose" includes classroom activities
2. The SGS Computer Network has not been established as a public access service or a public forum. SGS has the right to place reasonable restrictions on the material you access or post through the system. You are also expected to follow the rules set forth in BP & AR 6163.4 – Student Use of Technology and the law in your use of The SGS Computer Network.
3. You may not use The SGS Computer Network for commercial purposes. This means you may not offer, provide, or purchase products or services through The SGS Computer Network.
4. You may not use The SGS Computer Network for political lobbying. But you may use the system to communicate with elected representatives and to express your opinion on political issues.

B. Student Internet Access

1. All students will have access to Internet World Wide Web information resources through their classroom, library, or school computer lab.
2. Elementary students will have e-mail access only under their teacher's direct supervision using a classroom account. Elementary students may be provided with individual e-mail accounts under special circumstances, at the request of their teacher and with the approval of their parent.
3. You and your parent must sign an Account Agreement to be granted an individual e-mail account on The SGS Computer Network. Your parent can withdraw their approval at any time.
4. If approved by the principal and supervised by your classroom teacher, you may create a Web page using The SGS Computer Network. All material placed on your Web page must be pre-approved in a manner specified by the school. Material placed on your Web page must relate to your school and current classroom activities.

C. Unacceptable Uses

The following uses of The SGS Computer Network are considered unacceptable:

1. Posting Personal Information

- a. You will not post personal contact information about yourself or other people. Personal contact information includes your address, telephone, school address, work address, etc.
- b. You will promptly disclose to your teacher or other school employee any message you receive that is inappropriate or makes you feel uncomfortable.

2. Illegal Activities

- a. You will not attempt to gain unauthorized access to The SGS Computer Network or to any other computer system through The SGS Computer Network or go beyond your authorized access. This includes attempting to log in through another person's account or access another person's files. These actions are illegal, even if only for the purposes of "browsing".
- b. You will not make deliberate attempts to disrupt the computer system or destroy data by spreading computer viruses or by any other means. These actions are illegal.
- c. You will not use The SGS Computer Network to engage in any other illegal act, such as arranging for a drug sale or the purchase of alcohol, engaging in criminal gang activity, threatening the safety of person, etc.

3. System Security

- a. You are responsible for your individual account and should take all reasonable precautions to prevent others from being able to use your account. Under no conditions should you provide your password to another person.
- b. You will immediately notify a teacher or the system administrator if you have identified a possible security problem. Do not go looking for security problems, because this may be construed as an illegal attempt to gain access.
- c. You will avoid the inadvertent spread of computer viruses by following the District virus protection procedures if you download software approved by the District.

4. Inappropriate Language

- a. Restrictions against Inappropriate Language apply to public messages, private messages, and material posted on Web pages.
- b. You will not use obscene, profane, lewd, vulgar, rude, inflammatory, threatening, or disrespectful language.
- c. You will not post information that could cause damage or a danger of disruption.
- d. You will not engage in personal attacks, including prejudicial or discriminatory attacks.

e. You will not harass another person. Harassment is persistently acting in a manner that distresses or annoys another person. If you are told by a person to stop sending them messages, you must stop.

f. You will not knowingly or recklessly post false or defamatory information about a person or organization.

5. Respect for Privacy

a. You will not re-post a message that was sent to you privately without permission of the person who sent you the message.

b. You will not post private information about another person.

6. Respecting Resource Limits.

a. You will use the system only for educational activities.

b. You will not download large files unless absolutely necessary and only with approval of the District. If necessary, you will download the file at a time when the system is not being heavily used and immediately remove the file from the system computer to your personal computer.

c. You will not post chain letters or engage in "spamming". Spamming is sending an annoying or unnecessary message to a large number of people.

d. You will check your e-mail frequently, delete unwanted messages promptly, and stay within your e-mail quota.

7. Plagiarism and Copyright Infringement

a. You will not plagiarize works that you find on the Internet. Plagiarism is taking the ideas or writings of others and presenting them as if they were yours.

b. You will respect the rights of copyright owners. Copyright infringement occurs when you inappropriately reproduce a work that is protected by a copyright.

8. Inappropriate Access to Material

a. You will not use The SGS Computer Network to access material that is profane or obscene (pornography), that advocates illegal acts, or that advocates violence or discrimination towards other people (hate literature).

b. If you mistakenly access inappropriate information, you should immediately tell your teacher. This will protect you against a claim that you have intentionally violated this Policy.

D. Your Rights

1. Free Speech

Your right to free speech, as set forth in the BP & AR 5145.2 Freedom of Speech/Expression, applies also to your communication on the Internet. The SGS Computer Network is considered a limited forum, and therefore the School may restrict your speech for valid educational reasons.

2. Search and Seizure.

- a. You should expect only limited privacy in the contents of your personal files on the School system. The situation is similar to the rights you have in the privacy of your desk.
- b. Routine maintenance and monitoring of The SGS Computer Network may lead to discovery that you have violated this Policy, the AR 6163.4 Student Use of Technology or the law.
- c. An individual search will be conducted if there is reasonable suspicion that you have violated this Policy, the BP & AR 6163.4 – Student Use of Technology, or the law. The investigation will be reasonable and related to the suspected violation.
- d. Your parents have the right at any time to request to see the contents of your e-mail files.

3. Due Process

- a. The School will cooperate fully with local, state, or federal officials in any investigation related to any illegal activities conducted through The SGS Computer Network.
- b. In the event there is a claim that you have violated this Policy or BP & AR 6163.4 – Student Use of Technology in your use of the SGS Computer Network the Superintendent or designee may cancel or limit a student’s user privileges or increase supervision of student’s use of the District’s technological resources, as appropriate. Inappropriate use also may result in disciplinary action and/or legal action in accordance with the law and BP & AR 6163.4 – Student Use of Technology.
- c. If the violation also involves a violation of other provisions of the BP & AR 6163.4 – Student Use of Technology it will be handled in a manner described in the BP & AR 6163.4 – Student Use of Technology. Additional restrictions may be placed on your use of your Internet account.

E. Limitation of Liability

The School makes no guarantee that the functions or the services provided by or through the School system will be error-free or without defect. The School will not be responsible for any damage you may suffer, including but not limited to, loss of data or interruptions of service. The School is not responsible for the accuracy or quality of the information obtained through or stored on the system. The School will not be responsible for financial obligations arising through the unauthorized use of the system.

F. Personal Responsibility

Please be aware that everything you type, email or post etc. leaves an electronic footprint. Your use of the internet can be a mirror that will show you what kind of person you are.
