## 1:1 Device OPT OUT Program

Thank you for considering your student's participation in the distribution of devices as part of our 1:1 Device Program. We recognize there may be situations in which parents/guardians would prefer to provide their student with their own personal device instead of accepting a District provided device.

Please know that every student is required to have access to a device equivalent to the District provided device. If you plan to provide your student their own device, please read and acknowledge the information below.

For the current school year, students in 6<sup>th</sup> through 8<sup>th</sup> grades will receive one of the following devices:

Up to Intel Celeron N4020 (Dual Core, up to 2.8GHz, 4M Cache, 6W)  
Up to 32GB eMMC Hard Drive  
Up to 8GB 2400MHz LPDDR4 Non-ECC

This form must be completed and returned at the start of each school year. Please read the following information carefully. It is agreed and understood that:

- Participation in this program is totally voluntary. If a student does not accept the District provided device, they will be responsible for having their own device to access the electronic instructional materials and web-based tools.
- Assignments or tests will not be modified to accommodate specific requirements of devices brought to school under the 1:1 Opt Out Program. It will be the student's responsibility to complete all assignments as required.
- The District will not provide any technical support or repairs to personally owned devices nor will those students have access to any loaner devices should their personal device become inoperable.
- Any software required for use would need to be purchases by the student. The District cannot load District-Owned software on devices not owned or leased by the District.
- Devices in grades 6 through 8 that are brought to school via the 1:1 Opt Out Program must meet the requirements for state testing. Devices purchased from NCJUSD meet these requirements.
- Students who opt out of the 1:1 distribution may request to enter the program at anytime by completing the necessary paperwork and paying the applicable fees. To request a District provided device at a future date, parents/guardians should contact the School Office.
- Students are expected to follow the conditions of the Acceptable Use Policies and the Device Code of Conduct when operating / using their own device for/or at school.
- The District does not accept any liability for personal devices used at school. It is the student's responsibility to properly care for and store the device while at school. Personal devices brought to school are not covered by the District for any loss, damage, or theft.
